


## Montana Historic Preservation Grant Program

## 2027 Biennium Awarded Projects

The Montana Historic Preservation Grant Program is a state-funded program created in 2019 as a result of Senate Bill 338, Sections 1-17. The MHPG Program is designed to support public or private entities with the preservation of historic sites, historical societies or history museums through grant funding.

For the 2027 Biennium, a total of \$5,918,092 was awarded to 31 projects across the state.
